What data do we collect?

Ballintotas National School collects the following data:

• Personal Identification Information (you name and email address, if you provide it postal address and a phone number) when you send us an enquiry by email, phone or post.

How do we collect your data?

You directly provide Ballintotas National School with most of the data we collect. We collect and process your data, on a consent basis, when you:

- Enrol in the school
- Are a service provider whom we pay for a service
- Voluntarily complete a survey or provide feedback on any of our electronic mediums
- Use or view our website via your browser's cookies.

How will we use your data?

Ballintotas National School collects your data so that we can:

- Process your request and conduct the business of the school.
- Email you with requested information or information we feel is important e.g. school notices, important school related information, notices of interest to parents and wider school community.

How do we store your data?

Ballintotas National School securely stores your data on encrypted machines.

Ballintotas National School will keep your data for the length of time required to provide you with the service you requested from us and the duration legally required by the Department of Education and Skills.

Marketing

Ballintotas National School occasionally would like to send you information about school related information or notices that we think you might like if you have agreed to receive email, you may always opt out at any stage.

You have the right at any time to stop Ballintotas National School from contacting you for purely information purposes.

What are your Data Protection rights?

Ballintotas National School would like to make sure you are fully aware of all of your data protection rights. Every user is entitled to the following:

<u>The right to access</u> – you have the right to request of Ballintotas National School copies of your personal data. We may charge a small fee for this service.

<u>The right to rectification</u> – you have the right to request that Ballintotas National School correct any information you believe is inaccurate. You also have the right to request Ballintotas National School to complete information you believe is incomplete.

<u>The right to erasure</u> – you have the right to request that Ballintotas National School erase your personal data, under certain conditions.

<u>The right to restrict processing</u> – you have the right to request that Ballintotas National School restrict the processing of your personal data, under certain conditions.

<u>The right to object to processing</u> – you have the right to object to Ballintotas National School processing your personal data, under certain conditions.

<u>The right to data portability</u> – you have the right to request that Ballintotas National School transfer the data that we have collected to another organisation, or directly to you, under certain conditions.
